Confirmation of the horse's identity by DNA comparison to our DNA Database is required.*

IF THE ORIGINAL CERTIFICATE OF REGISTRATION IS NOT AVAILABLE WITH THIS HORSE, A DUPLICATE CERTIFICATE WILL HAVE TO BE ISSUED AT THE DUPLICATE CERTIFICATE CHARGE. A TRANSFER FEE WILL ALSO APPLY.

NASHA By-Law Article IX Section 15. In case of change of ownership of an animal, the seller is required to submit to the Secretary a completed application for transfer and pay for the same. Blanks for transfer may be obtained from the Secretary and from the website. If the seller does not transfer the horse within sixty (60) days or send in the registration certificate for cancellation, the owner will be suspended from conducting business; and no new business will be conducted until the business in question is concluded. In cases of willful neglect or refusal of seller to give a transfer without reasons satisfactory to the Board of Directors, the record of change of ownership may be made by the Secretary upon written approval of the Board upon satisfactory evidence of sale and delivery. If the Seller of an animal is not the last recorded owner on the registration certificate, DNA Verification shall be required. Forms may be obtained from the Secretary. Fee is to be set by the Board of Directors and may be changed at any time.

After this form and payment is submitted, NASHA will send a DNA kit to the possessing owner of the horse via USPS. The possessing owner should follow the directions on the DNA kit and send the hair sample to the Veterinary Genetics Lab at Texas A&M University (address on kit).

Please send completed form and payment in U.S. Funds to the office address provided below. DNA Verification applications received incomplete, including fees, will be subject to delays in processing, or may be returned without processing. ALL FEES ARE NON-REFUNDABLE AND NON-TRANSFERRABLE.
